根据欧洲的相关法规，雇主必须向雇员提供安全保护，以确保雇员在安全的环境下工作，安全鞋是其中一个重要部分。CE标志不是质量保证的标志，标有CE标志的安全鞋表明该产品符合所有欧盟相关条例——个人防护装备指令（PPE—Personal Protective Equipment Directive 89/686/EEC）的要求，CE标志具有强制性，只有取得CE标志的安全鞋才能在欧盟28个国家内销售。

从2005年8月1日起，欧盟又提高了对进口欧洲安全鞋的技术壁垒，采取了新的认证标准 EN ISO 20344/20345/20346/20347，增加了一些新的测试项目和规定。

Challenge

According to European regulations, employers must provide adequate safety protection for employees to ensure that they work under safe conditions. Safety footwear is an important part of personal protection equipment. The CE Mark is not quality-mark. Safety footwear bearing CE Mark indicates conformity with all the requirements of EU Personal Protective Equipment Directive 89/686/EEC. CE Mark is mandatory for safety footwear, which must obtain CE mark to be placed on the markets of 28 European countries.

On and from Aug 1, 2005, Europe raised higher technical barriers for safety footwear imported into Europe by introducing new certification standard EN ISO 20344/20345/20346/20347 and adding in new testing items and requirements.

So the industry is facing the problems of how to satisfy the requirements for safety footwear set by European countries, and obtain CE Marking successfully.

- A. (EN 345) Footwear with toe caps offering an impact resistance of 200 Joules and compression resistance of 15,000 Newtons.
- B. (EN 346) Footwear with toe caps offering an impact resistance of 100 Joules and compression resistance of 10,000 Newtons
- C. (EN 347) Footwear without steel toe caps offering other forms of protection.

Testing according to the category of safety footwear

- 1) Safety performance testing, mainly including:
Toe impact resistance; toe compression resistance; sole penetration resistance; cut resistance of upper
- 2) Hazardous chemical substance testing, mainly including: PH value, leather Cr(VI), AZO, PCP

Technical File

Declaration of Conformity

The CE Marking itself is not meant to provide details about the product to surveillance authorities. The declaration of conformity contains information adequate for tracing the product. Intertek provides expert help and advice in compiling your Declaration of Conformity:

- * A list of the Directives and Standards that your product conforms to.
- * Product identification.
- * The manufacturer's name, address and signature.



Assessment of Technical File

Intertek has been authorized by the Department of Trade & Industry of EU to assess technical files of safety footwear and issue CE Mark.

Affix the CE Mark to your product

EU has specific rules to adhere to in CE Marking. These rules address the size and dimension of the marking, affixing the CE Mark to products, packaging and material or documents shipped with the product and specific limitations on when and who is permitted to affix the CE Mark. Intertek will give you expert advice on these requirements.
